Corporate Account Application Form and Declaration of Consent

It is important that you carefully and diligently fill in all sections of the form below.

Bespoke Trustees Limited ("Bespoke"), Tower Trade Finance (Ireland) Ltd ("TTFI") and Conexim Advisors Ltd ("**Conexim**") have an obligation to capture a number of details about you to satisfy Anti Money Laundering Requirements, as well as for your investment advisor to assess the suitability of investments for you, and for Conexim Advisors to assess the appropriateness of relevant investments or services that may be provided to you (where applicable). The account you are making an application to open is a general investment account, where you can purchase a broad range of investment instruments, as described more fully in the Conexim General Terms of Business.

Conexim is regulated by the Central Bank of Ireland under Regulation 11 (1) of the European Communities (Markets in Financial Instruments) Regulations 2007, and as an insurance intermediary under the European Communities (Insurance Mediation) Regulations, 2005 (as amended).

Please note that if you invest in the TTFI Loan note, this investment does not require licensing, authorisation, or registration with the Central Bank of Ireland and as a result, it is not covered by the Central Bank of Ireland's requirements designed to protect consumers or by a statutory compensation scheme.

Conexim will not carry out an assessment of the suitability or the appropriateness of such an investment on your behalf.

Part 1 Identity Documentation

In order to comply with Anti-Money Laundering regulations we require additional information in order to verify your name and address. Please provide the documentation as outlined below.

Corporate / Trust Documents

We require the following:

- A certified copy of the Certificate of Incorporation of the Company
- A certified copy of the Memorandum and Articles of Association of the Company
- A certified copy of the most recent audited accounts
- 2x Proof of Registered Address (and Mailing address if different) - e.g. Utility Bill or Bank statement

If this is a Trustee account, we may require additional information concerning Trust deeds, Beneficiary details and in some cases, details of the settlors and protectors of the Trust.

Authorisation and Signatory Mandate

A mandate of the Board of the Directors, signed by a minimum of two Directors, as well as any individuals nominated to act on behalf of the company, authorising Conexim to set up the account and to accept instructions.

Name Verification for Directors / Authorised Signatories

An original (if you see us in person), or a certified copy of current valid passport or full Irish drivers license. (A certified copy is one that has been signed and stamped as 'a true copy of the original' by a solicitor, commissioner for Oaths, Garda, chartered accountant, bank official or a regulated entity, or another designated person as understood under The Criminal Justice (Money Laundering and Terrorist Financing) Act 2010 (as amended).

Address Verification for Directors / Authorised Signatories

Two forms of proof of address, which can include:

- Utility Bill (Gas, electricity, local authority bill, landline telephone bill etc - no mobile phone bills will be accepted)
- Bank statement, credit union statement or credit card bill
- Current balancing statement from Revenue Commissioners
- Social insurance documents
- Current Household/motor insurance documents (a quotation is not acceptable)
- Notification of Determination of Tax Credits or Tax Clearance Certificate

(An original or certified copy of each item above is accepted and must be less than three months old)

If this is a Trustee account, we may require additional name and address verification information concerning Beneficiaries and in some cases, settlors and protectors of the Trust.

4.3. Receipt and Consent of Order Execution Policy

I have received enclosed information regarding both Conexim and PSL's Order Execution Policy, and by signing this document I consent to having my orders executed as set out in those policies.

4.4. Express Consent to Execution of an Order outside of a Regulated Market or MTF

4.6. Fees, Commissions and Charges
